

Disclaimer of participation in 'Mattie Griffin Wheelie School'

This disclaimer states that you, as a participant, agree to take part in the 'Mattie Griffin Stunt & Wheelie School' at your own risk and responsibility.

You are solely responsible under civil and criminal law for any damage caused by you or the vehicle you use during the event. All participants renounce, by their signature below, for all accidents or damages suffered in connection with the event, to any right of action or recourse against the organizer, the site owner and their employees, instructors, helpers or agents, authorities, auxiliary services or other persons, which are related to the organization of the event. By signing this disclaimer this Agreement becomes effective.

Participants must be experienced motorcycle rider.

The participants has to wear complete motorcycle protective clothing:

Textile with protectors (elbow, shoulder, back, hips and knees, alternatively knee pads) or leather suit. Full face motorcycle helmet (undamaged!), Gloves and motorbike boots right up to the ankles and most flexible! Enduro and motocross boots protect, but are very stiff and hinder the feel of the foot brake and motorcycle. Racing boots with ankle, foot and joint protection are better suited than cheap touring boots that only protect against wetness.

Only drivers with proper protective clothing are allowed to participate in the Wheelie School.

The organizer, his instructors and helpers are very keen on helping the participants to finish the workshop successfully. However, there is no guarantee that the participants will fully master a 'wheelie' after the workshop. It depends on many factors, including current skill set of a participant, obedience to instructions and implementing learned techniques during the event.

In the event of severe weather conditions Wheelie School may be postponed to a later date without an option for a refund.

Cancellation policy: We do NOT offer refund in any circumstances.

The organizer reserves the right to refuse to admit the participants who are negligent in their instructions or those whose behavior is inappropriate and rude; who are suspected of being under influence of alcohol or drugs; who didn't sign, agreed and understood the disclaimer, without refund under any circumstances.

Deductible if the vehicles are damaged:

The organizer reserves the right to charge a fee for damage caused by fall, failure to follow instructions from the instructors, concealment of health restrictions (both physical and mental), overconfidence and especially negligence (only judged by the organizer and the instructors!) to claim the affected participant.

The participation fee is:

600 € for fall damage (handlebar, armature, plastic, foot pegs, light, brake and shift lever, etc.)

1.200 € for irreparable damage (engine, frame, electrics, control units, etc.)

I, Mattie Griffin DO NOT perform 'wheelies' on public roads and I DO NOT RECOMMEND to do so, to any of the participants at the 'Wheelie School' learning experience. 'Wheelie' should only be performed in suitable and safe environment.

I, Mattie Griffin hope that the basics of disclaimer will allow all participants to be considerate of themselves, each other, the equipment and the motorcycles, so that no one will be harmed and everyone will experience the desired driving pleasure at the 'Wheelie school'.

By signing this agreement, I agree to hold **Mattie Griffin, Weston Aviation Academy Limited and all staff involved** entirely free from any liability, including financial responsibility for injuries incurred, regardless of whether injuries are caused by negligence.

I also acknowledge the risks involved in taking part in **'Wheelie School'**. These include but are not limited to any **injuries (bruise, broken bone, cuts, serious injuries etc.) even death**. I swear that I am participating voluntarily, and that all risks have been made clear to me.
